4. TRANSFER OF DATA TO THIRD COUNTRIES AND PROFILING

6. CONSEQUENCES OF FAILURE TO PROCIE DATA AND WITHDRAWAL OF DATA PROVISIONING

The data processing purposes outlined in point 2 of this notice primarily serve to present the data processing aspects of Villa 11's service portfolio. The processing of data indicated in the table is carried out based on consent, performance of a contract, or legal requirements. Please note that providing your personal data is a prerequisite for the provision of our services, as failure to do so will prevent us from providing services to you. It's important for you to know that if the data processing is based on your consent, you can withdraw it at any time; however, this does not affect the lawfulness of processing carried out before withdrawal based on consent or legal obligations (see GDPR Article 13(2)(c)).

7. YOUR RIGHTS (SO-CALLED DATA SUBJECT RIGHTS)

Below is a brief summary of your data subject rights. If you would like detailed information on these, please feel free to contact us!

As a data subject, you have the right to request information about the data processing necessary for Villa11's operations at any time. You may also request the correction or completion of your personal data if you believe that your data has been inaccurately recorded in our system.

If you no longer wish for your data to be processed, you can exercise your right to have it deleted, as you have the right to withdraw your consent to data processing given earlier at any time. It is important to note that the Data Controller cannot delete data that is required by law to be processed or necessary for the exercise of third-party rights (e.g., information used in civil or criminal proceedings). If deemed necessary, you may request the restriction of processing related to you, based on your right to restriction.

You are entitled to receive the personal data provided by the Data Controller in electronically recorded form (right of access), and you may also request that this data be transferred to another data controller. This can be done free of charge once a year.

You also have the right to lodge a complaint and seek judicial remedies, the guidelines for which can be found in point 5 of this notice.

You can send your request regarding the exercise of your data subject rights to the notification address specified in point 1 of this notice. We will investigate and respond to your request within one month. If necessary, with appropriate notification, we may request an additional two months to conduct our investigation.

8. FINAL PROVISIONS

This notice has been prepared in accordance with the requirements of Regulation (EU) 2016/679 of the European Parliament and of the Council (GDPR), repealing Directive 95/46/EC.
